Voter Information

D.C. RESIDENTS

REGISTERING TO VOTE
Check your voter registration and update any information at www.dcboe.org
Contact your public library or DC Bord of Elections (DCBOE) for a registration application
Register to vote by email or mail.
DCBOE must receive your application by deadline of Oct.13
You can same-day register at any Vote Center from Oct.27 – Nov. 3
VOTING PROCEDURES
Absentee/Mail-In Ballots
Automatically mailed to all registered residents at their registered address. To be received the first week of October . You do not have to request an absentee ballot.
Follow ALL instructions for filling out your ballot. Sign where indicated and double check everything before sealing the envelopes.
Deposit your voted ballot in a Mail Ballot Drop Box before 8:00 pm on Nov. 3 (Find A Drop Box at: http://bit.ly/DC_dropbox)
Mail your ballot by Oct. 20 to guarantee it is counted.
Vote In-Person
Early vote in person at ANY Early Vote Center from Oct. 27-Nov. 2
Early Vote Center hours are 8:30 am-7:00 pm (Find Early Vote Centers at: http://bit.ly/DC_EarlyVote)
Vote in Person on Election Day (Nov.3) at ANY Election Day Vote Center. Election Day Vote Centers hours are 7:00 am – 8:00 pm . (Find Election Day Vote Centers at: http://bit.ly/DC_VoteCenters)

Tips from the U.S. Postal Service

- *Mail your ballot at least 7 days before election day.*
- *Add postage to the return envelope if needed.*

REGISTERING TO VOTE

The deadline to register to vote is **October 13, 2020**.

To register to vote, update or verify voter registration information use Maryland's Online Voter Registration System (OLVR); **or**

Use the Federal Post Card Application Register available at www.fvap.gov; **or**

VOTING PROCEDURES

Absentee/Mail-In Ballots

You must be a Maryland registered voter; have a valid Maryland driver's license; or have a MVA issued ID card.

The deadline to request a mail-in ballot by mail is **Tuesday, October 20, 2020**.

You can request a mail-in ballot by downloading a copy of the form at www.elections.maryland.gov; or request a ballot online at:

<https://voterservices.elections.maryland.gov/onlinemailinrequest>.

You can request a mail-in ballot by TEXT to:

"VBM" TO 777-88. You will receive a text message with a link to request your mail-in ballot online.

You can go to local Board of Elections and obtain a mail-in ballot. Visit www.elections.maryland.gov for listing of local Board of Elections.

You can find email addresses and fax numbers to your local election office at: www.elections.maryland.gov/about/county_boards.html.

If you want someone to pick up your ballot for you, they must be at least 18 years of age; you must provide a *Designation of Agent* form. Obtain the form from your local elections office or visit www.elections.maryland.gov/voting/absentee.html.

You will receive an email confirmation that your mail-in ballot request has been processed.

Requested ballots will be mailed to you 30-45 days before election day.

Upon receiving your mail-in ballot, using black ink **mark (do not sign)** the ballot, **sign** and seal the return envelope:

- by mail - return your ballot using the postage-paid return envelope;
- by hand deliver – take your ballot to your local election office, [e.g., Prince Georges’ County Board of Elections 1100 Mercantile Lane Suite115A Largo, MD 20774]. Visit www.elections.maryland.gov for listing of local Board of Elections; or
- drop your ballot in your local drop-off box (A list of Drop off box will be included with your mail-in ballot).

You **CANNOT** return your voted ballot online.

Mail-in or dropped-off ballots must be postmarked or placed in a designated drop box by **8:00 pm on November 3, 2020**.

Vote In-Person

Early voting will be held for 8 days and begin on **October 26, 2020 through November 2, 2020**. You can vote at any Early Voting Center. (See listing of Early Voting Centers at: www.elections.maryland.gov. Click on the Early Voting Centers (PDF) link.)

Election Day is **Tuesday, November 3, 2020**.
